Information for Stallholders

Site tickets available from 7am-7.50 am on market morning.

In order not to miss out on a site you are advised to buy your ticket at the previous market from 8.30 am – 12.30 pm. Alternatively, you may phone/email the secretary to make a confirmed booking, advising your full name, address, telephone number, date of the market, the site fee, and your Driver's License ID number. Stall sites must be available for the date required for you to obtain a ticket with this method, and site availability cannot be guaranteed. Tickets pre-paid for are NOT NEGOTIABLE.

SITE ACCESS

Stallholders must not enter the reserve before 8.00 am and all sites must be vacated by 1.30 pm.

Public purchasing large objects will have to carry their purchases to either end of a row and **a committee member will be required to escort the vehicle onto the reserve for pick-up.**

Stallholders are required to obey the directions of committee members at all times. After three warnings you will not be permitted to attend the market if you continue to disobey.

UNUSED TICKETS

If a ticket is unused for any reason other than a postponed market, that ticket will be forfeited. If a market is postponed due to inclement weather, the unused ticket may be used the following week at a special market provided the reserve is available. The unused ticket may not be used for any other scheduled market.

PERMITS AND IDENTIFICATION

It is the stallholder's responsibility to obtain any licenses or permits that may be required by the council or government.

Driver's licence ID must be produced when purchasing a ticket, when first registering. If a stallholder fails to purchase a ticket prior to entering onto the reserve, that stallholder will be required to pull to one side (losing their place in the line) to purchase a ticket and produce identification. Anyone refusing to give identification will not be permitted to set up a stall.

PUBLIC LIABILITY AND OTHER INSURANCES

The market operators carry insurance to cover their own liabilities. Stallholders are advised that these insurances do not cover the activities of the stallholders and they should carry their own policies.

GOODS THAT MAY BE SOLD

The Original Open Market is controlled by strict Council guidelines to support home and cottage industries. Goods permitted are second-hand from your home, homemade, home grown, or value added by you. Homemade food is to be accompanied by a copy of Public Liability Insurance, and also a copy of the City of Onkaparinga Food Assessment form. Please inquire for more specific information if you are concerned.

GOODS THAT MAY NOT BE SOLD

Goods either commercially or professionally manufactured and sold from a business, live animals, illegal substances, firearms, weapons, alcohol, tobacco products, commercial foodstuffs, new goods, broken unserviceable or unusable items, items prepacked or sold for distribution elsewhere, motor vehicles.

HANDCRAFT

Stallholders offering handcraft of any type are required to display a sign at least an A4 size (telephone book cover) stating "Home Made Hobby-craft"

GUARANTEES

All stallholders are required to stand by their guarantees.

RULES

It is required that the market Conditions of Admission be obeyed at all times.
